IThis workshop reviews the responsibilities of a mandated reporter of child abuse or neglect in California, as well as examine the categories of "child abuse" and "neglect" as defined in the California Child Abuse and Neglect Reporting Act (CANRA). Participants will:

- Understand the definitions of child abuse, maltreatment, and mandated reporting.
- Know how to recognize the signs of potential abuse or maltreatment in the children they serve.
- Define reasonable suspicion in the context of California child abuse reporting.
- Improve their understanding of the definitions provided in the Child Abuse Reporting and Neglect Act for each of the categories of abuse and neglect.
- Understand their responsibilities as mandated reporters in California and know the process for when and how to make such reports.

- •Participants will be able to explain the difference between general neglect and severe neglect.
- Participants will be able to name 3 definitions or examples of sexual abuse.
- Participants will be able to identify 5 risk factors associated with the commercial exploitation of children (CSEC).
