#### **COURSE DESCRIPTION & EDUCATIONAL GOALS:**

Latinx are the largest ethnic-minority group in the U.S. making up about 18% of the population and are likely to become the largest minority group to utilize mental health services in the near future. Compared to their U.S.-born White counterparts, first-generation Latinx immigrants have higher rates of psychological distress, in part due to immigration-related stressors such as language barriers, familial separation, and financial strain.

This workshop covers the basics of Latinx demography, culture, & therapy principles with Latinx families. Educational goals include:

- Learn the basics of Latinx demography, culture, & therapy principles with Latinx families.
- Develop a pro-cultural/immigration narrative highlighting Latinx families' suffering, strengths, & resilience based on facts /research.
- Learn basics facts about immigration & DACA (Deferred Action for Child Arrivals) that have large impacts on these families.
- Learn ways to build rapport with Latinx clients, including advocacy & case management.

#### **LEARNING OBJECTIVES:**

- Participants will identify 5 ways to build rapport with Latinx clients.
- Participants will explain 4 impacts of DACA and immigration on Latinx families.
