### COURSE DESCRIPTION & EDUCATIONAL GOALS:

This workshop is intended to deepen participants' understanding of the advancement of telemental health. Topics to be discussed include: Measures to protect clients and providers legally and ethically; Ways to ensure providers are compliant with current Federal and CA State telemental health services practice guidelines.

After completing this course, participants will be able to provide ethically and legally sound telemental health services compliant with Federal and CA State regulations and feel confident in their knowledge to execute competent telemental health services.

### LEARNING OBJECTIVES:

- Participants will identify the most common legal and regulatory considerations of providing telehealth services.
- Participants will name the four mandatory steps required to occur prior to initial telehealth service delivery in CA.
- Participants will name the three requirements that must be documented at the beginning of each telehealth session.
- Participants will be able to identify 3 potential ethical risks in the provision of telemental health with children, couples, families.
- Participants will be able to identify 3 ways to mitigate risk of ethical violations in the provision of telemental health with children, couples, and families.
